2. The N.O.C. of the Government of Punjab is granted to start new institute for the course C.P.Ed. (50 seats) in favour of S.K.R. College of Physical Education Bhagoo Majra, Teh. Kharar, Distt. Mohali from the Session 2006-07 subject to the following conditions:-

- i) That the applicant Society is registered Society and has sufficient land in the name of society and building as per norms of N.C.T.E.. The Land use as Educational purpose will be obtained from the competent Authority.
- ii) That the applicant Trust will construct the requisite building on the land already earmarked for this purpose and completion certificate of the building will also be obtained from the competent authority, as per norms and standards.
- iii) That the applicant society will also obtain clearance of affiliating University.
- iv) That the management of the Trust will ensure that the conditions of basic requirements/norms and standards of the Punjab Government/Punjabi University, Patiala/N.C.T.E. are fully complied with.
- v) That no financial assistance/grant will be provided by the Government to this Institute.
- vi) That in case, if at any stage, any limit for fees is prescribed by the Government, the Institute will comply the same.
- vii) That this approval is provisional and the same can be withdrawn at any time without any prior notice.
- viii) For the subject combinations, the institute will offer the subjects as per directions, if any, of the affiliating University/Punjab Government.

WHEREAS in terms of Section 14 (1) of the NCTE Act, 1993 **S.K.R. COLLEGE OF PHYSICAL EDUCATION, BHAGOO MAJRA, KHARAR MOHALI, PUNJAB** had submitted an application (Code No. APN02948) to the Northern Regional Committee of National Council for Teacher Education for grant of recognition / permission for starting C.P.ED Course of 2 year duration with an annual intake of **100 students**.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the Affidavit and the inputs received from the Visiting Team in the form of report and videography, the Committee is satisfied that the Institution / society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the Secondary Teacher Education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc for running the programme and has selected / appointed duly qualified teaching staff as per NCTE norms.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **S.K.R. COLLEGE OF PHYSICAL EDUCATION, BHAGOO MAJRA, KHARAR MOHALI, PUNJAB** for conducting C.P.ED course of 2 years duration with an annual intake of **50** students in the 1st year and the same for the IInd year under clause 7 (12) of NCTE Regulation dated 13th Jan 06 subject to fulfillment of the following :-

- (i). The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account to be operated along with an official of the Regional Committee.
- (ii) The Institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, as amended from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government, etc, wherever applicable.

5. The Institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the Statement of Annual Accounts duly audited by a Chartered Accountant.
